Your Thoughts on the Perch Limit for NYS Waters?

Perhaps you recently participated in the survey put out by the NYS Department of Environmental Conservation regarding raising the daily limit of walleyes on Oneida Lake. (The Fall issue of the *OLA Bulletin* will have a comprehensive article on this issue. Arriving in your mailbox/inbox soon!)

The DEC is also turning its attention to studying perch size limits and bag limits in NYS waters. They are conducting a brief survey to learn more about the views of New York anglers on yellow perch fishing on inland waters. DEC is accepting responses until October 23rd.

Your OLA Board of Directors encourages you to have your voice heard. We look forward to hearing about your responses.

Reminder: Although the DEC is currently considering raising the daily limit of walleyes on Oneida Lake to five, keep in mind that there has been no final decision.

In the meantime, the daily limit of walleyes remains at three!

UPDATE FROM DEC

On September 29, 2020, DEC received a report of a black discharge, believed to be sewage, to the Oneida Creek. DEC conducted an immediate investigation which determined the City of Oneida Sewage Treatment Plant (STP) experienced a problem caused by industrial wastewater that reduced the plant's ability to provide proper treatment. The City is currently working to fix the situation to bring the plant into compliance as soon as possible. DEC continues to closely monitor the plant's operation to ensure all steps are being taken to comply with the stringent requirements in place to protect public health and the environment.

On Oct. 13, DEC issued a formal Notice of Violation to the City to ensure all appropriate corrective actions are expeditiously completed, and that measures are put in place to prevent future non-compliance. Additionally, the City is currently under a DEC Consent Order that requires significant upgrades to the STP to replace aging infrastructure and to provide enhanced treatment of the industrial wastewater it receives. The upgrades are scheduled to be completed by December 2022.
